
It's your **Museum of Our National Heritage** in Lexington, Massachusetts, supported by **your** generous donations in the annual **Blue Envelope** appeal.

Celebrating its tenth anniversary year, the museum will have on exhibit—Fraternally Yours: A Decade of Collecting, an exhibition of decorative arts with fraternal symbolism. The exhibit, which runs through January 12, 1986, features objects from the museum's unique collection.

The exhibition is one of several special events and exhibits celebrating the yearlong 10th anniversary of the museum. In 10 years of collecting material associated with fraternal societies, the museum's growing collection has become a unique resource. The collection documents the history of many organizations, both thriving and defunct, attempting to place each group in its historical context and emphasize its contribution to American social history.

Founded in 1975, the Museum of Our National Heritage is a museum and library of American history featuring changing exhibits on America's growth and development from its founding to the present. Located in historic Lexington, Massachusetts, it was the




Bicentennial project of the Scottish Rite of Freemasonry in the Northern Jurisdiction of the US.

An attendance of more than 2,200, composed of nearly 1,100 Thirty-third Degree Masons and their ladies, is expected to visit Detroit between September 20-26 as the Supreme Council for Scottish Rite Freemasonry in the fifteen-state Northern Jurisdiction holds its 173rd Annual Meeting.

This year's Supreme Council sessions, will be highlighted by the conferral of the Thirty-third Degree on 156 Scottish Rite Masons who were chosen to receive the high honor at the Council's 1984 meeting at Boston. The Thirty-third Degree is awarded for outstanding achievement in the Fraternity or for significant contributions to others reflecting credit on Freemasonry. The impressive ceremony will take

place in Detroit's Ford Auditorium on Wednesday evening, September 25th.

Executive business conferences attended will occur on Friday, September 20th. Business sessions continue on September 21st followed by the annual dinner for the governing body.

Large scale events begin on Sunday afternoon, at the Vesper Service.

Visiting members and their ladies will be welcomed to tours of Detroit's noted Masonic Temple on Monday morning and afternoon, September 23rd.

General meetings of the Supreme Council will occur at the Ford Auditorium on Tuesday and Wednesday, September 24th and 25th, when prominent leaders from other Masonic organizations in the United States, Canada, Mexico, Europe, and South America will join Northern Jurisdiction members for report and discussion periods.

A number of other events have been scheduled including a luncheon for all ladies present, September 24th, at which Mrs. Dorothy R. Maxwell, wife of the Sovereign Grand Commander, will preside.

The 1985 meeting will conclude on Thursday forenoon, September 26th, with a final general session at the Westin Hotel and with the announcement of the names of those elected to receive the Thirtythird Degree at Cincinnati in September, 1986.


