#### I Didn't Know That!

Born Ehrich Weiss, the son of Rabbi Mayer S. Weiss in Appleton, Wisconsin, he changed to the stage name of Harry Houdini and later legally had his name changed to that. He was a member of the daylight Lodge of Entertainers in New York City, St. Cecile Lodge No. 568.

His death came from a bizarre

His death came from a bizarre encounter. Speaking to students in Montreal, he boasted about the strength of his stomach muscles and his ability to withstand blows. Without warning, a student punched him twice above his appendix. Although he did not complain at the time, the pains started as he boarded the train for Detroit.

Arriving at Detroit, he was taken to Grace Hospital where it was learned he had sustained a burst appendix that sent poison all through his body. He died of peritonitis, October 31, 1926, Halloween

Eve.

Before his death, he and his wife Beatrice, entered into a solemn agreement that whoever died first would try to contact the other from the Great Beyond. This never came about.

ILL.. ROBERT FRANKLIN CASE, 33°

Active Member, former Deputy for the State of New York, and Grand Secretary General of this Supreme Council, died on Wednesday, June 13, 1990, at his home in Scotia, New York, following a long illness.

Ill.: Robert Franklin Case, 33°, was born in Troy, Pennsylvania, on July 13, 1924, the son of A. Henry and Margaret (Davidson) Case. He attended the public schools and graduated from Troy High School in 1941, Phillips Exeter Academy in Exeter, New Hampshire in 1942, and Dartmouth College in Hanover, New Hampshire with a Bachelor of Arts Degree in political science in 1949.

In his youth he was active in Scouting and served as a Scout Honor Guard for the King and Queen of England at the 1939 New York World's Fair. He also held the title of Marble Champion for Northern Pennsylvania and Southern New York and was a contender for the National Championship title at the National Marble Tournament at Ocean City, New Jersey.

In April 1943, his college education was interrupted by a three-year Army enlistment. He was commissioned a 2nd Lieutenant at Fort Benning, Georgia, and saw action in the European theatre which took him to Germany at the end of World War II. He received several combat decorations including the Purple Heart and Bronze Star with Oak Leaf Cluster and a battlefield promotion to 1st Lieutenant. His interest in the military continued after the war and he spent several years in the New York Army National Guard. At the time of his retirement from the Guard in 1964, he held the rank of Lieutenant Colonel, Infantry Battalion Commander.

On August 20, 1945, he married Mary Frances Wood of Troy, Pennsylvania, who survives along with their daughter, Carolyn M. Queal of Grand Junction, Colorado; and four sons, Davidson W. of Arlington, Texas; A. Henry and Jonathan E., both of Gunnison, Colorado; and R. Marshall of Blue Bell, Pennsylvania. He is also survived by his stepmother, Mrs. Sophia P. Case; a sister, Mrs. Adelle Picking, his brother, John P. Case, and four grandchildren.

Immediately following graduation from Dartmouth College in 1949, Ill.: Brother Case joined the General Electric Company at Schenectady, New York, in its Financial Management Program. He held a variety of managerial assignments and in 1971 was named Manager of the Schenectady Utilities Operation at the Company's main plant. He was a graduate of the Management Development Program at Rennselaer Polytechnic Institute and of the General Management Course at the Company's Management Institute at Crotonville, New York. In 1959, he served as president of the General Electric Management Association and was the 1975 recipient of the national award for community service presented by General Electric's Elfun Society, a company-wide senior management association. He retired from the company in 1983.

Ill.. Brother Case was active in his community as a Trustee of the Ellis Hospital Foundation, the Ingersoll Home for Aged Men, and the Troy Savings Bank. He was a member of the Schenectady County Deputy Sheriff's Association; the Armenia Debating Society of Troy, Pennsylvania; the Mohawk Golf Club; and the Scotia Rotary Club. He was a former member of the board of directors of the United Way of Schenectady and also served as its president and chairman. He was also a Board Member of the Schenectady YMCA, Schenectady Chapter of the American Red Cross, Junior Achievement, Travelers Aid and the Community Welfare Council.

In the town of Glenville, he was the town Republican chairman, former chairman of the Board of Assessment Review, a former Assessor, and member of the Planning and Zoning Committee.

In 1964, he was named a Schenectady Patroon by the Mayor, Malcolm E. Ellis. He was a charter member of the Capital District Transportation Authority, serving from 1970 to 1978 by gubernatorial appointment. He was currently a judicial delegate in the Fourth Judicial District of New York.

In church work, Ill.: Brother Case had served as a Deacon of the Freehold Presbyterian Church, Charlton, New York. More recently he attended the East Glenville Community Church, and the First Reformed Church of Schenectady, New York.

Our Illustrious Brother's long and distinguished Masonic record follows:

Raised a Master Mason in Trojan Lodge No. 306 F. & A.M., Troy, Pennsylvania, on September 14, 1948, affiliating with Corlaer Lodge No. 932, F. & A.M., of Schenectady, New York, in 1955, and was its Master in 1984. He was a Director of the Masonic Research Laboratory in Utica and was recognized by receipt of the Charles Henry Johnson Medal bestowed by the Grand Lodge of New York. He was appointed Grand Representative of the Grand Lodge of Maryland near the Grand Lodge of New York in 1986.

CAPITULAR:

Exalted in Warren Chapter No. 23, R.A.M., of Ballston Spa, New York, April 16, 1970, affiliated with St. George's Chapter No. 157, of Schenectady, New York, in May 1990. In 1988, he was awarded the Distinguished Service Medal by the General Grand Chapter, R.A.M., International.

**CRYPTIC:** 

Greeted in St. George's Council No. 74, R. & S.M., of Schenectady, New York, on October 13, 1976.

CHIVALRIC:

Knighted in Holy Cross Commandery No. 51, K.T., of Gloversville, New York, in 1971, and affiliated with St. George's Commandery No. 37, K.T., of Schenectady, New York, in 1980.

**SCOTTISH RITE:** 

Completed the degrees of the Scottish Rite in the Valley of Schenectady on April 21, 1950. He was the Thrice Potent Master of Sigma Lodge of Perfection in 1961-62 and Commander-in-Chief of Sigma Consistory in 1969-71. He was the recipient of the Meritorious Service Award in 1967.

#### SUPREME COUNCIL:

On September 24, 1969, at Boston, Massachusetts, he was created a Sovereign Grand Inspector General, 33°, Honorary Member of the Supreme Council, and crowned an Active Member at Boston, on September 25, 1975. He was the Grand Marshal General 1978-86, Deputy for New York 1985-89, a member of the Administrative Council 1987-90, and was the Grand Representative near the Northern Jurisdiction of the Supreme Council for the Netherlands 1980-90. He was elected Grand Secretary General at the annual meeting held in Boston, on September 30, 1987.

Ill.: Brother Case performed various Special Assignments and served on the following committees:

Masonic Education and Program Development, 1977-87 Ritual and Ritualistic Matters, 1983-90 General State of the Rite, 1985-90 Records, 1987-90 Special Committee to Study Jurisdictional Lines, 1977-79

He was a member and secretary of the Board of Directors of the Trustees of the Supreme Council, 1987-90.

He was also a member of the Board of Directors of the Museum of Our National Heritage, 1981-85, 1987-90.

Ill.: Brother Case was a member of Cyprus Temple, A.A.O.N.M.S., in Albany, New York, and was its Potentate in 1973. He was also a member of Albany Court No. 77, Royal Order of Jesters; Albany Conclave, Red Cross of Constantine; Giles Fonda Yates Council No. 22, Allied Masonic Degrees; Long Island Chapter No. 86, National Sojourners; the Royal Order of Scotland; and was a recipient of the DeMolay Honorary Legion of Honor.

A funeral service was held on Monday, June 18, 1990, at the First Reformed Church with the Rev. Vincent Falsano officiating. It was preceded by a brief 33° Masonic Service conducted by Ill.: Herbert T. Singer, 33°, with 51 members of the Supreme Council participating. The well-attended church service included a large contingent of Masonic friends and associates headed by Ill.: Francis G. Paul, 33°, Sovereign Grand Commander; Ill.: Stanley F. Maxwell, 33°, Sovereign Grand Commander Emeritus; Ill.: Sidney R. Baxter, 33°, Assistant to the Sovereign Grand Commander; Ill.: Robert L. Miller, Sr., 33°, Deputy for Indiana; Ill.: Richard W. Parker, 33°, Deputy for Vermont; Ill.: Carlton A. Winchester, 33°, Deputy for New York; Ill.: James F. Nichoff, 33°, and Ill.: Harold F. Dates, 33°, Active Members for New York. Present also were M.W. Roswell T. Swits, 33°, Immediate Past Grand Master and R.W. Sheldon K. Blank, 33°, Deputy Grand Master, and a number of present and Past Grand Lodge officers in New York.

Interment was at Glenwood Cemetery, Troy, Pennsylvania.




He served in the United States Army from 1942 to 1945 and saw duty in Africa, Sicily, Corsica, France and Germany.

He is presently employed as a Sanitary Engineer by the New York State Department of Environmental Conservation in the Division of Construction Management.

Police Helicopter to transport child emergency burn victims in Northern N.Y.S.; Saranac Lake Pee Wee Hockey Program; Franklin & Essex Counties and N.Y.S. 



Brother Widger has been active in other community and professional organizations as well. He served on the Marcellus Town Planning Board for 15 years and was Chairman of the Zoning Board of Appeals.

He was a Trustee of the Skaneateles Savings Bank for 16 years and is a Director of the Farmers and Traders Life Insurance Company. He is also a member of the New York State College of Veterinary Medical Advisory Council; the New York State Agricultural Society; the New York State Veterinary Medical Society; the American Veterinary Medical Association; the Association of Bovine Practitioners; and the New York State Association of Professions, Inc. He is a Past President, Onondaga County Veterinary Society and member of the County's Agricultural District Advisory Committee.

Brother Widger also holds membership in the National Grange; New York State Grange; and the Onondaga-Pomona Grange. He is Past Master of the Marcellus Subordinate Grange. He is also Past President of the Marcellus Rotary Club in which he held membership for 11 years.


