# **Corner Stone-laying Ceremony Supreme Council Headquarters**

# July 29 celebration all-day family gathering

The Supreme Council of the Northern Masonic Jurisdiction of the ancient Accepted Scottish rite will hold a cornerstone-laying ceremony on July 29th for its newly renovated headquarters in Lexington, mass. Grand Master of Masons in Massachusetts, Fred K. Bauer, will perform the ceremony. A representative from each of the 15 grand Lodges will assist the Grand Master.

The dedication marks several new beginnings for Supreme Council headquarters.

The Supreme council and support staff, the Information Systems department, The Northern Light magazine editorial office and administrative personnel of the 32° Masonic Learning Centers for Children will all be housed under the same roof for the first time.

More importantly, a new 32° Masonic Learning Center for Children will also be on site.

The Center will tutor up to 60 dyslexic children free of charge and become one of a network of 55 proposed Masonic Learning Centers across the jurisdiction.

The ceremony kicks off an entire weekend of

festivities planned at the Lexington headquarters and the adjacent Scottish Rite Masonic Museum of Our National Heritage. To commemorate the newly renovated headquarters and learning center, as well as the 25th anniversary of the museum, the Scottish Rite has planned familyoriented events on the grounds throughout the day. Events include a family-style picnic, roving barbershop quartets, an antique auto display, and more. The museum will be hosting musical entertainment during the afternoon.

Masons from all over the 15-state jurisdiction will be in attendance to witness the ceremony.



# **ELECTED TO RECEIVE THE 33°**

Pittsburgh will be the site of this year's annual meeting of the Scottish Rite Supreme Council for the Northern Masonic Jurisdiction. More than 2,500 Thirty-third Degree Masons and their ladies from 15 north-eastern states are expected at the meeting on Sept. 24-27. The Supreme Council last met in Pittsburgh in 1989.

The 2000 Session will be highlighted by the conferral of the organization's Thirty-third Degree upon 318 Scottish Rite Masons who were elected for this high honor at last year's meeting in Atlantic City, New Jersey. This year's millennium class will be the largest in recent years. The Thirty-third Degree is awarded for outstanding achievement in the fraternity or for significant contributions to others, reflecting credit on Freemasonry. The impressive ceremony will take place on Tuesday, Sept. 26, in the Pittsburgh Convention Center.

Introductory luncheons honoring the Thirty-third Degree candidates and their ladies will be on the schedule for Sunday noon.

Earlier business conferences attended by the Active Members and officers of the Supreme Council will be held on Friday and Saturday, Sept. 22-23.

The larger-scale events will begin on Sunday afternoon, Sept. 24 when the Pittsburgh Convention Center will be the scene of the traditional Supreme Council Vesper Service. The Rev. Dale R. Smith, 32° will deliver the Vesper message. He is Senior Minister, Level Green Community; Past District Superintendent of the Western Pennsylvania Conference of the United Methodist Church; and Past Grand Chaplain of the Grand Lodge of Pennsylvania. Assisting will be Sovereign Grand Commander Robert O. Ralston, 33°; Grand Prior Kenneth V. Kettlewell, 33°, Interim Pastor, Second Presbyterian Church in Cambridge, Ohio; and Rev. Richard G. Morledge, 32°, Pastor Emeritus, First Presbyterian Church in Bakerstown, PA; Past Dean of the Chapel at Grove City College; and Past Grand Chaplain of the Grand Lodge of Pennsylvania.

Grand Commander Ralston will preside over the General Sessions of the Supreme Council on Monday, Sept. 25. In the course of these sessions, prominent leaders from other Masonic organizations in the United States and throughout the world are expected to be in attendance.

A number of other events have been scheduled, including a Monday luncheon for all ladies attending the Pittsburgh meeting. Mrs. Susann Ralston, wife of the Grand Commander, will preside over the luncheon and program. At the same time, another luncheon will be served for all Supreme Council members, distinguished guests, and members of the millennium class.

That evening, the Pittsburgh Pops Orchestra will present a concert in Heinz Hall. During the week, special sightseeing tours will be available for those attending the meetings.

In addition to the major events sponsored by the Supreme Council, a Masonic Marketplace will allow vendors to display Masonic-related items.

A series of seminars on Tuesday will cover topics of interest for those attending the session.

Throughout the week, there will be many smaller social functions occurring under the auspices of the 15 participating states and the 108 Valleys comprising the Northern Jurisdiction.

The 2000 meeting will end with the announcement of the names of those elected to receive the Thirty-third Degree at Indianapolis, Indiana, in September 2001

# PRIORS CORNER

It seems prayer still upsets some people.

When Minister Joe Wright was asked to open the new session of the Kansas Senate, everyone was expecting the usual generalities, but this is what they heard:

"Heavenly Father, we come before you today to ask Your forgiveness and to seek Your direction and guidance. We know Your Word says, 'Woe to those who call evil good,' but that is exactly what we have done.

"We have lost our spiritual equilibrium and reversed our values. We confess that.

"We have ridiculed the absolute truth of Your Word and called it Pluralism.

"We have worshipped other gods and called it multiculturalism.

"We have endorsed perversion and called it alternative lifestyle.

"We have exploited the poor and called it the lottery.

"We have rewarded laziness and called it welfare.

"We have killed our unborn and called it choice.

"We have shot abortionists and called it justifiable.

"We have neglected to discipline our children and called it building self-esteem.

"We have abused power and called it politics.

"We have coveted our neighbor's possessions and called it ambition.

"We have polluted the air with profanity and pornography and called it freedom of expression.

"We have ridiculed the time-honored values of our forefathers and called it enlightenment.

"Search us, Oh, God, and know our hearts today; cleanse us from every sin and set us free. Guide and bless these men and women who have been sent to direct us to the center of Your will, and we ask it in the name of Your son, the living Savior, Jesus Christ. Amen."

The response was immediate. A number of legislators walked out during the prayer in protest. In six short weeks, Central Christian Church, where Rev. Wright is pastor, logged more than 5,000 phone calls with only 47 of those calls responding negatively. The church is now receiving international requests for copies of this prayer from India, Africa, and Korea.

Commentator Paul Harvey aired this prayer on "The Rest of the Story" on the radio and received a larger response to this program than any other he has ever aired.

With the Lord's help, may this prayer sweep over our nation and wholeheartedly become our desire so that we again can be called one nation under God.

Our 32° Masonic Learning Centers for Children have and continue to enjoy extraordinary growth and success.

Much of that success has been related to the efforts and direction of Mrs. Phyllis Meisel, who has served our charity since its inception as a part time consultant. As such Mrs. Meisel was responsible for clinical operations, even while she maintained a full time position at Massachusetts General Hospital in Boston.

We have now grown to twenty-six 32° Masonic Learning Centers for Children in operation, and we continue to plan for 8 to 10 additional centers each year until we reach our goal of 55 centers.

With this growth, our need for a full time Corporate Clinical Director is very apparent.

It is my pleasure to announce that Illustrious and Doctor Richard Van Doren, 33° has accepted the position of Corporate Clinical Director, effective the first week of June.

Brother Van Doren's professional background as a clinical psychologist, as a member of the Corporate Professional Advisory Committee, as well as his Masonic career, provide us with a person we believe is uniquely and deeply qualified to fill the position of Corporate Clinical Director. (Please find attached a copy of his resume). He and his family will be relocating to the Boston area.

I know you will join Phyllis and me in congratulating Ill. Brother Richard Van Doren, and wishing him every success as he joins our Corporate Staff.

It is also my pleasure to inform you that Mrs. Phyllis Meisel will remain on our staff and looks forward to working with Richard in a part time capacity. She will continue as Clinical Director of the Newtonville, Massachusetts, 32° Masonic Learning Center for Children.

### THE HISTORY OF FREEMASONRY

No one knows with certainty how or when the Masonic fraternity was formed. A widely accepted theory among Masonic scholars is that it arose from the stonemasons' guilds during the Middle Ages. The language and symbols used in the fraternity's rituals come from this era. The oldest document that makes reference to Masons is the Regius Poem, printed about 1390, which was a copy of an earlier work. In 1717, four lodges in London formed the first Grand Lodge of England, and records from that point on are more complete.

Within thirty years, the fraternity had spread throughout Europe and the American Colonies. Freemasonry became very popular in colonial America. George Washington was a Mason, Benjamin Franklin served as the head of the fraternity in Pennsylvania, as did Paul Revere and Joseph Warren in Massachusetts. Other well-known Masons involved with the founding of America included John Hancock, John Sullivan, Lafayette, Baron Fredrick von Steuben, Nathanael Greene, and John Paul Jones. Another Mason, Chief Justice John Marshall, shaped the Supreme Court into its present form.

Over the centuries, Freemasonry has developed into a worldwide fraternity emphasizing personal study, self-improvement, and social betterment via individual involvement and philanthropy. During the late 1700s, it was one of the organizations most responsible for spreading the ideals of the Enlightenment: the dignity of man and the liberty of the individual, the right of all persons to worship as they choose, the formation of democratic governments, and the importance of public education. Masons supported the first public schools in both Europe and America.

During the 1800s and early 1900s, Freemasonry grew dramatically. At that time, no social "safety net" had been provided by the government, and the Masonic tradition of founding orphanages, homes for widows, and homes for the aged provided the only security many people knew.

Today in North America, the Masonic fraternity continues this tradition by giving almost \$2 million each day to causes that range from operating children's hospitals, providing treatment for childhood language disorders, treating eye diseases, funding medical research, contributing to local community service, and providing care to Masons and their families at Masonic homes.

The four million Masons worldwide continue to help men and women face the problems of the 21st century by building bridges of brotherhood and instilling in the hearts of men ideals for a better tomorrow.
