In 1767 Stephen Morin's close associate Henry Francken transported this new Masonic Rite to Albany, New York, where he formed first Ineffable Grand Lodge the **Perfection** in North America, with civil engineer Bro. William Gamble serving as its first master. The following year, the first Grand Council of Princes of Jerusalem was organized here. These lodges were the forerunners of what was to become the Ancient Accepted Scottish Rite in the United States (and Canada). Thus, the Valley of Albany is the oldest valley in the Northern Masonic Jurisdiction, and the second oldest valley in the United States.....

# Message from: ILL.: Peter J. Samiec 33° Area Active

Greetings all...

Things change. The last message I prepared was written on a fine summer day; today I'm writing with my back to the window so I don't have to witness the snow and freezing falling through the 25° temperatures.

Things will change again. As the snowplow rumbling by changes the conditions on the street, nature will change the weather and it'll be warm and sunny when I write again.

Nothing is as permanent as change. The weather proves it. A glance in the mirror reinforces it. Necessity creates it.

Several things changed as a result of deliberations at last year's Supreme Council session in Washington, DC. And, like the weather, some of the decisions will be viewed as warm and sunny, others cold and snowy.

I think we can all feel good about the changes in our degree structure. Several degrees were modified to make conferral more user-friendly to large and small Valley alike. A new 26<sup>th</sup> Degree (Friend and Brother Eternal) has been added, replacing the Lincoln Degree, which is now available for public presentation and the order of presentation of the 31<sup>st</sup> and 32<sup>nd</sup> Degrees are no longer required to be sequential.

Supreme Council is preparing 2 new membership development DVDs, Entitled "The Last Full Measure", and "Introduction to 32° Masonry" and has put in place a Master Insurance Plan that will reduce the cost of insurance for most Valleys, and eliminate the expense completely for others.

In the four years that I've been an Active Member of our Supreme Council, I've found that, from the top down, our leadership is attuned to the membership and willing to listen and consider the input received. This is made evident by some of the decisions and implementations mentioned above.

There are committees, such as the Strategic Planning/State of the Rite

Committee, who evaluate, discuss and make recommendations to other committees, based on input from our members. It's a process I'm glad to be a part of.

However, a change that might not be so well received is an increase in our assessment structure. Changes in our membership numbers and operating costs have necessitated an increase in our annual assessment to insure that Supreme Council is able to maintain the level of services our members have come to expect. Consider this: from 1960 (further back than that, I'm sure) Supreme Council has increased its assessment only once, from \$3.00 to the current level of \$8.50. speculate that every one of us reading this has experienced only that one assessment increase of \$5.50 during his entire Scottish Rite experience.

Our Supreme Council presently operates and supports its Valleys, members and charities on a budget of over \$7,500,000 per year. With the present dues paying membership just under 200,000, that budget reflects a cost of over \$40 per member for the overall services and programs currently provided. The present \$8.50 assessment, however, is supporting less than 20% of the total budget.

In order to reduce this gap, the Supreme Council assessment will increase from its present level of \$8.50 to \$27.00 by the year 2014, made in increments of \$3.00 per year after an initial increase of \$3.50 this year. With regard to Article 313-7, Life Memberships, any member who is presently on record as being a life member, (as of 12/31/07) will be exempt from this increase. Also, no Senior Member will be affected by this increase.

My Brothers, we can no more ignore the need for this increase than I can ignore the ice and snow outside my window. We can turn our back on it and look at it negatively, but the facts remain. We can't operate our Supreme Council in 2008 on 1960 income. Change is the motivating factor, and we need to understand and accept the fiscal mandates that this change requires. On March 29<sup>th</sup> our Valley secretaries will receive

additional information regarding this increase that can be passed on to our members. If you have questions, they'll have answers. Before you form an opinion regarding the assessment increase, get all the facts available. Then you can make an informed judgment rather than a knee jerk reaction.

It's my sincere hope that your love of Scottish Rite Masonry and your passion for our great works will temper any reservations you may have regarding this increase, and you'll help us maintain the high standards we've all come to love, respect and appreciate as Scottish Rite Masons.

#### "Secretary's Notes"

Sublime Princes, we are in the middle of a new year in our Valley, under the leadership of Ill. William M. Korn, 33., Commander In Chief. We had a successful Fall Reunion, initiating eleven new members, several of whom have expressed an interest in taking parts in our degrees. Three new Brothers have joined the ranks of officers: Bro. Eric Benson is the new Captain of the Guard in the Lodge of Perfection, Bro. Isaiah M. Kirk is the new Master of Ceremonies in the Council of Princes of Jerusalem, and Bro. Olivier Francois is the new Captain of the Guard in the Chapter of Rose Croix.. Bro. Kenneth M. White has expressed a renewed interest in holding an elected office and will be running for the office of Junior Warden in May.

Bro. Drew A. Millier became a member last Spring and has accepted responsibility as the new degree director for the 18th degree. In the Spring Reunion, we will be conferring the 20th degree, formally known as the "Master Ad Vitam" degree, but informally known as the "Washington degree" under the direction of Bro. Benjamin T. Garry. A group of Brothers from the Greene County area has also taken responsibility for conducting the "Brother of the Forest" degree, informally known as "the Indian degree" under the direction of Ill. Ronald H. Noll. We will be doing a degree exchange with the Valley of Schenectady.

We have discovered a need for a minor revision to our Bylaws. We must amend Section 9 to conform to Article 338 of the Constitutions. The Executive Board will vote on the

change. Then the general membership will vote at annual meeting May 29, 2008.

Reminder:

Due to a change in Article 402 the

Constitution of the Supreme Council, we must suspend membership after one year in arrears in dues payment. Accordingly, any member not having paid his 2007 dues (which were due before July 31, 2007) by the end of this fiscal year will face suspension. Please do not let this happen to you!

Supreme Council assessments will increase with the 2009 dues statement coming in July and will increase through the year 2014. As stated in the

Constitutions, "Each Lodge of Perfection shall pay to the Supreme Council with its annual return made to the Supreme Council as of July 31st of each year, an assessment in the sum, based upon the Supreme Council fiscal of August 1 to July 31st, of eight-dollars and fifty cents for 2007 and thereafter for each 4th Degree member of such Lodge of Perfection, based on its membership as of June 15th of each year, such amount being required for the expenses of the Council." This amount, Supreme payable in July of 2008 will be increased by \$3.50 per member in 2009 and by \$3.00 each year of the following five years until the year 2014.

While I am not encouraging anyone to request a demit, it is the honorable approach for any member wishing to terminate his membership. It allows the member to return to membership in the Scottish Rite and does not cost his Valley the value of unpaid assessments levied by our Council of Deliberation and Supreme Council.

I encourage all members to come out to our meetings and especially our Reunions. Members have renewed their commitment to improve their proficiency in the degrees and we have new stage sets that will make you proud to be a member of our Valley. We have been adding many new members each year, but it is difficult to keep ahead of the Angel of Death.

There are interesting programs or degrees performed at our regular meetings so you can be assured of receiving value for your time. Our Valley continues to update its web site and I encourage you to search it for information about your Valley. The current address is:

People with dyslexiz never outgrow dyslexia. Reading and writing remain difficult throughout their life, but with specialized tutoring by a professional trained to work with dyslexics, they can manage print more effectively.

**Honorary Member of the Supreme Council** 



Ronald H. Noll was born January 17, 1934 in Albany, New York. He attended the Albany Public Schools, graduating in 1953. Following graduation he entered the US Army and served with the 24th Infantry Division in Korea, and was Honorably Discharged in 1956.

After being employed for ten years with New York Telephone, Brother Noll joined State Bank of Albany where he held various positions until he retired after 36 years of service in 1994 (he retired from Fleet Bank which was formerly State Bank then Norstar and is currently Bank of America). His last responsibility with the Bank was Facility Manager in the beautifully refurbished old Union Railroad Station. Ron was raised February 27, 1957 in Wadsworth Lodge #417 -- was Master in 1973, then Treasurer until 1997. He served as District Deputy Grand Master for the Albany District for the years 1988 & 1989. He is a member of the Valley of Albany, Scottish Rite, currently serving as Treasurer -- is a Past Most Wise Master of the Albany Sovereign Chapter of Rose Croix and is an active participant in several Degrees. He received the Meritorious Service Award in 2002.

Brother Noll is a member of the Cast in Cyprus Shrine -- a Shepherds driver for Shriners Hospital -- President of the Albany Masonic Hall Association and President of Capital District Masonic Charities. Ron is a Past Master Councilor of DeMolay and was awarded the Legion of Honor in 1987. Ron has also been active in a number of community organizations including the Salvation Army, Kiwanis Club, American Red Cross, and American Heart Association.
