#### A Message from your Commander in Chief

Sublime Princes:

Recent Scottish Rite leadership conferences and articles have taught us the concept of "ICE" which stands for Inspiration, Convenience, and Enjoyment. I was asked recently to comment on the success we have had promoting these ideas and, upon reflection, I am proud to report that ICE is alive and well in the Valley of Albany. Actually, I believe we have always conducted our affairs in Albany relying on ICE. We just didn't know the acronym.

#### INSPIRATION

We strive to inspire our members by planning interesting programs at our regular joint meetings. In this way, the members know they are not traveling to Albany for just a business meeting. If everyone knows the Officers will be present and prepared for the meeting which will include a well planned program, they are inspired to attend. Of course, having a light meal before the meeting and/or collation after the meeting further inspires participation. This past year we have seen member participation increase by approximately 20-30%. As an example, we enjoyed a Saturday evening Testimonial Dinner for our newest MSA and 33rd Degree recipients with 75 members and guests in attendance. Also, there were more than 35 members present at our Annual Meeting. We held our first 32<sup>nd</sup> Degree Banquet on June 19th after the conferral of the Consistorial Degrees. This banquet was an open affair where the wives, children, and guests presented their new Sublime Prince with his black hat and AASR lapel pin. This innovation appeared to inspire enthusiastic participation from everyone in attendance. Finally, our recent addition of the Knights of the Double Eagle and Knights of St. Andrew units have been very popular among our members who enjoy wearing Scottish regalia and receiving gold tone jewels. The one hundred participants of the Knights of the Double Eagle receive points for participation in Valley events and functions. This year we were the first Valley in the Northern Masonic Jurisdiction to knight our first nine Knights of the Double Eagle. There are now two additional Valleys that have been inspired by the Valley of Albany to institute this innovation.

#### **CONVENIENCE**

Convenience is a little harder for the Valley of Albany since we meet in the Albany Masonic Hall where parking can be an issue. However, arrangements have been made to have inside parking at an adjacent garage at a discounted fee which makes this less of an issue. Additionally, we have tried to conduct our Reunions over several days so the candidates and participants do not have to try to assimilate all of the degrees in one day. As you will notice from reviewing the 2010-2011 Trestle Board contained in this edition, this year we plan to conduct one set of degree conferrals throughout the year at various locations that will culminate with the Consistory Degrees and the Second Annual 32<sup>nd</sup> Degree Banquet. It is my hope that this schedule will make the degree process more enjoyable for everyone. In the same way as last year, meals and collation will be provided so that attending meetings and Valley events will be more convenient for members who are not able to go home or eat out before joining us. Finally, we will institute a better and timelier way to communicate with our members so that remembering when Valley meetings and functions are scheduled will be easier. In this manner, we can also better allocate our limited time and resources. I believe adequate and timely communication is critical to making our lives more ordered and attendance at meetings and Valley events more convenient.

#### **ENJOYMENT**

Finally, it is my belief that the natural result of inspiration and convenience is

enjoyment. All of the above-referenced innovations are intended to make participation in Scottish Rite Masonry more enjoyable for our members, degree candidates, and potential degree candidates. The feedback I have received from many of our members is that they like what we are doing and look forward to attending Valley We have members who functions. regularly travel great distances to attend meetings, Reunions, and special events. In addition, more of our senior members have decided to join us. At our 2010 Annual Meeting, I was pleased to share my dinner table with five Sublime Princes who have an average membership of approximately 40 years. I can honestly say that everyone enjoyed themselves and were pleased to show their support.

You have all heard me preach that our Valley is on the cusp of greatness. Through your help and support I believe we are well on our way to achieving this goal. The efforts we have taken this past year have accomplished our initial goal of energizing the members of the Valley by reminding them why they joined AASR and giving them a reason to come home again. This coming year we will concentrate on innovative changes that will include presenting degrees in "remote locations" in our Valley that are closer to where our newer members live. We can all be very proud that our efforts will ensure that the oldest Valley in Scottish Rite Masonry will enjoy many more successful years.

It is a terrific communication tool for sharing with and communicating among our members. #### "One Cause"

Many of you may have noticed three options for giving on your 2011 dues statement. Two are well known: Blue Envelope Appeal which supports the Abbott Scholarship Award program, and Child Learning Centers (CLC) which supports existing or soon-to-be learning centers for Children with Dyslexia. The third option, "One Cause" is not really a charity except for Life and Senior Exempt members who owe no dues. Any monies allocated to that fund are returned to the Valley for allocation to the Hospitaler's Fund.

Regular members may use the One Cause program to gradually offset their annual dues. To offset dues, go to the Supreme Council web site: www.SupremeCouncil.org and click on "Members Center". Once on the page entitled "Membership Services", scroll down to "One Cause". Click on One Cause and a page will open, giving an explanation of the program. The icons for the merchants and vendors that appear on the page represent those who have agreed to participate in the Supreme Council program. Through the purchase of their products and/or services on line, a percentage of the cost is put into an account and applied to your dues at the end of the year. A member must first establish an account through Supreme Council and then refer to that account when making on line purchases through our network of merchants.

While on the Supreme Council web page, visit the other programs being offered by Supreme Council. We have announced many of these services at meetings and reunions in our valley over time, but the web site presents them all in one place with an explanation of each.

Stay tuned, the name will soon be changing but the benefits will remain and be even better

#### Masons On Line (MOL)

During 2009, the Valley of Albany began a subscription to Masons on Line. Masons On Line is a password protected database that serves the needs of many Masonic organizations in the Capital Region, including Cyprus Shrine and Sigma Bodies.

#### Access to MasonsOnLine.org

Access to the site is restricted to members of participating organizations by use of a username and password requirement through the web page <a href="https://www.masonsonline.org">www.masonsonline.org</a> Once on the web page, type your username and password in the boxes that will appear on the first page (they are not case sensitive).

URL: <a href="www.masonsonline.org">www.masonsonline.org</a>
Username: <a href="clast name and">(last name and</a>
initials of first and middle name)

Password: <u>(use the PW you will be given by the Secretary)</u>
Once logged on to the web site, click on the *Display Group Info* menu item to display lists of the various groups within an organization..

Use the *Change Group* submenu button to change groups. For example, you will find the *Albany AASR* organization under *Masonic Organizations*, *Scottish Rite Valley*.

Click on the Albany AASR menu item, then click on *Valley Members*. You will find your name listed along with all the other members of the Valley.

Use the *Display Events Info* button to display a calendar of upcoming events and use the *Change Org List* to include all (participating) organizations. Check the box of each organization you wish to view.

For more information on an event, click on the event. If an event has an r.s.v.p., click on that event to reserve your place. Experiment with the menu options. Always click on menu items. Never use the "back" key.

Once you are familiar with MOL, the Secretary/Administrator for the Valley will send you a more complete set of instructions on using MOL.

### "Re-Member The Blue Lodge Program".

You may not be aware of this program since it was introduced a few years ago. This is a program that is meant to say "Thank You" to any members of the Scottish or York Rite that has been a first line signer of a petition for any New York Blue Lodge member. Once the new initiate has been raised as a Master Mason, the Rite member who is a first line signer is encouraged to secure an application for this recognition from his Valley Secretary and forward it to the Lodge Secretary who will fill in the appropriate information. We have several applications in process at this time. If you have sponsored a new member within the past two years, you may use the form below to initiate the process.

My Brothers,

Your intrepid editor has asked for an update on the progress of our project to establish a Learning Center for Dyslexic Children. As you know, the Valleys of the Capital District have been working on this for some time. Over the course of this summer, the Steering Committee, which consists of members representing all Scottish Rite Bodies in the Capital District, met twice and took a number of concrete steps to move this project forward.

The most important thing is that we've secured a site in Columbia County that has the approval of the Supreme Council. Now the real work begins as we plan to mold the empty space into classrooms and meeting areas. We're drafting a budget and are exploring candidates for the position of Director of the Center.

Of course, all this presupposes the fact that we can raise the necessary funds to operate a Center for the long term. For the immediate future, the focus of the steering committee will be on raising this money. I know that each of the Valleys will be hearing more on this directly as we emerge from the summer hiatus.

We'd like to involve more people from each of our Valleys in this project. Your presiding officers would be glad to enlist volunteers. The idea of becoming part of a project that will improve the quality of life for many children ought to be motivation enough. Our model of teaching has proven itself successful across the country. What's important now is that we make common commitment to move forward and contribute to the success of the project in whatever way best uses our individual talents and abilities.

Appropriately enough, the Annual Walk-a-thon to benefit Children with Dyslexia is coming up on September 25<sup>th</sup> at The Crossings in Colonie. Details on the walk are printed elsewhere in this issue of *The Rite Light*. I urge you to participate in some way to this worthy cause, either by walking and collecting pledges, supporting friends who are walking, or by sponsoring a sign for the course. Together, we can do great things to improve the lives of those around us. Joining the effort to support the Learning Center is a great opportunity to do just that.
